✓Confederació de Comerç de Catalunya wants to gather together interlocutors from Retail and Services sector, in order to be stronger and to provide a better service to society.

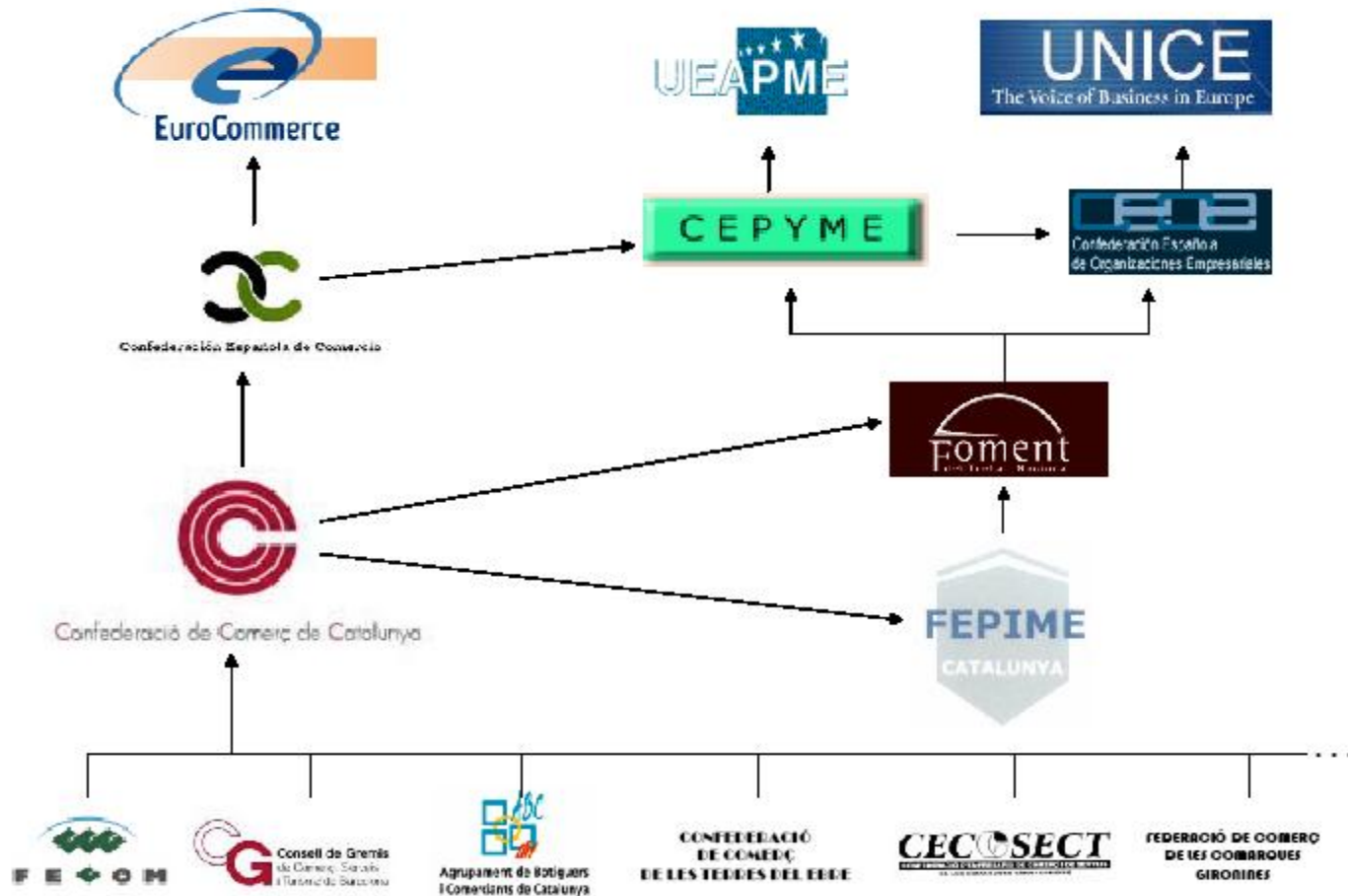
